Feature Event – To begin no later than 7:00 p.m.

QUALIFICATIONS Two (2) laps to be run consecutively with the faster lap counting as official qualifying time. The fastest 16 cars are locked in to the Feature Event. The remaining cars will run the qualifying race, transferring the top two (2) finishers to the A-Main (starting in positions 17 and 18). Those competitors running in the qualifying race that transfer to the A-Main Event will be allowed to buy two tires for the Feature event. Position 19 and 20 will be provisionals. Qualifying tires must be for the A-Main Event. Qualifying race will be run straight up.

FEATURE EVENT – 100 LAPS – 20 Cars Start. Cars will start according to invert, followed by remaining four transfers from qualifying event and provisionals. Those transferring from the qualifying race will fill the remaining feature positions in the order of the finish from the qualifying race.

Purse Money will be paid at the completion of the event.
